AN ORDINANCE REVERTING THE AMOUNT OF THREE MILLION TWO HUNDRED SIXTY SEVEN THOUSAND NINE HUNDRED FORTY TWO PESOS AND SIXTY THREE CENTAVOS (P3,267,942.63) FROM THE PERSONAL SERVICES SAVINGS OF VACANT POSITIONS FROM JANUARY TO JUNE 2019 AND APPROPRIATING THE SAME FOR THE GRANT OF TERMINAL LEAVE BENEFITS, CASH GIFT, CLOTHING ALLOWANCE AND PERFORMANCE-BASED BONUS TO QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE AND ACQUISITION OF VEHICLE (ADDITIONAL).

WHEREAS, there exists an available fund in the amount of Three Million Two Hundred Sixty Nine Thousand Seven Hundred Forty Eight and Forty Two Centavos (P3,269,748.42) representing Personal Services Savings (Vacant Positions) from January to June 2019;

WHEREAS, the amount of Three Million Two Hundred Sixty Seven Thousand Nine Hundred Forty Two Pesos and Sixty Three Centavos (P3,267,942.63) is appropriated for the grant of Terminal Leave Benefits, Cash Gift, Clothing Allowance and Performance-Based Bonus to Qualified Municipal Officials of the Municipality of San Nicolas, Ilocos Norte and Acquisition of Vehicle (additional);
