A RESOLUTION REQUESTING THE HON. FRANCISCO G. DATOL, JR., REPRESENTATIVE OF THE SENIOR CITIZEN PARTYLIST, AT THE HOUSE OF REPRESENTATIVES TO EXTEND FINANCIAL ASSISTANCE AMOUNTING TO TWO MILLION PESOS (P2,000,000.00) TO THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE FOR THE CONSTRUCTION OF A SENIOR CITIZEN’S BUILDING IN THE MUNICIPALITY.

WHEREAS, the Local Government Unit (LGU) of San Nicolas, Ilocos Norte has included in its plans and programs various infrastructure programs which are marked priority as these are deemed immediate needs of the various sectors of society;

WHEREAS, the LGU thru the MPDC and the Municipal Engineer have identified the construction of a Multi-Purpose Building (Senior Citizens Center) in the Municipality of San Nicolas, Province of Ilocos Norte as one priority undertaking;

WHEREAS, the above mentioned project is included in the Local Development Investment Program as well as the CY 2019 Annual Investment Program of the municipality;

WHEREAS, one of the requirements set forth is a Sangguniang Bayan Resolution endorsing the above stated project to the concerned national agencies, thus, it was;

RESOLVED as it was hereby **RESOLVED BY THE** Sangguniang Bayan assembled in session to Request the Hon. Francisco G. Datol, Jr., Representative of the Senior Citizen Partylist at the House of Representatives to Extend Financial Assistance Amounting to Two Million Pesos (P2,000,000.00) to the Municipality of San Nicolas, Province of Ilocos Norte for the Construction of a Senior Citizen’s Building in the Municipality.

On motion of Member Norberto D. Dadiz, Sr., duly seconded, foregoing resolution was unanimously approved.


