"RESOLUTION NO. 2019-169

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE 1 COOPERATIVE INSURANCE SYSTEM OF THE PHILIPPINE LIFE AND GENERAL INSURANCE (1 CISP) FOR THE RENEWAL OF GROUP INSURANCE COVERAGE FOR BARANGAY TANODS AND TRAFFIC AIDES.

WHEREAS, the municipality, aside from providing services to its constituents, is also engaged in the extension of insurance coverage to its constituents;

WHEREAS, the cooperative agrees to enroll its traffic aides and barangay tanods with 1 CISP's Group Yearly Renewable Term (GYRT) insurance plan;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."

Page 2, Resolution No. 2019-169;

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the 1 Cooperative Insurance System of the Philippine Life and General Insurance (1 CISP) for the Renewal of Group Insurance Coverage for Barangay Tanods and Traffic Aides.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;
