A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE BLACK NAZARENE HOSPITAL INC. FOR THE PROVISION OF AMBULANCE TO THE DAMILI BIRTHING HOME OF STA. CECILIA, LOCATED AT BARANGAY 23, STA. CECILIA, SAN NICOLAS, ILOCOS NORTE.

WHEREAS, the Black Nazarene Hospital, Inc. is an Ambulance Service Provider that operates by transporting sick or injured patients to, from the between places of treatment by land;

WHEREAS, the Black Nazarene Hospital, Inc. is a part of the functional referral system network in the area or vicinity of where it is allowed to operate;

WHEREAS, the Local Government Unit of San Nicolas, Ilocos Norte in the operation of its Birthing Home, the Damili Birthing Home of Sta. Cecilia located at Brgy. 23, Sta. Cecilia, San Nicolas, Ilocos Norte, shall establish tie-up with an ambulance provider;

WHEREAS, the Local Government Unit of San Nicolas, Ilocos Norte in return shall refer patients and recommend services unavailable from them to the Black Nazarene Hospital, Inc.;

WHEREAS, the use of the ambulance by the Local Government Unit of San Nicolas, Ilocos Norte is in accordance to the existing rules and regulations and policies in the use of ambulance imposed to the users by proper authorities and by the Ambulance Provider to protect the public and assures the safety of patients;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

XXX XXX XXX

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

- (b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:
- (vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Black Nazarene Hospital Inc. for the Provision of Ambulance to the Damili Birthing Home of Sta. Cecilia, Located at Barangay 23, Sta. Cecilia, San Nicolas, Ilocos Norte.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;
