“RESOLUTION NO. 2019-171

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE UNIVERSITY OF STO. TOMAS (UST) RELATIVE TO THE PROTECTION OF CULTURAL HERITAGE AND PROMOTION OF TOURISM PROGRAMS OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, the Municipal Government of San Nicolas, Ilocos Norte is the primary planning, programming, coordinating, implementing, and regulatory local government in the protection, conservation, development, and promotion of the cultural heritage of San Nicolas, Ilocos Norte for the economic benefit of its constituent and enhancement of the Filipino people in the international community;

WHEREAS, the University of Santo Tomas through Conservation of Cultural Property and Environment in the Tropics (CCCPET) an applied research center of the Graduate School constantly endeavors to provide consultancy, research, training and project development in heritage conservation and sustainable development;

WHEREAS, recognizing that partnership with bodies that will support or implement programs, projects and activities that promote and protect San Nicolas becomes a stronger and more collaborative platform in pursuit of sustainable development in line with Philippine priorities and development agenda;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to enter into a Memorandum of Understanding (MOU) with the University of Sto. Tomas (UST) Relative to the Protection of Cultural Heritage and Promotion of Tourism Programs of San Nicolas, Ilocos Norte.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;


On motion of Member Juanito P. Ulep, Jr., duly seconded, foregoing resolution was unanimously approved.
