“RESOLUTION NO. 2019-176

A RESOLUTION REACCREDITING THE SAN PABLO SMALL WATER IMPOUNDING SYSTEM IRRIGATORS ASSOCIATION, INC. AS A CIVIL SOCIETY ORGANIZATION OPERATING IN THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE.

WHEREAS, Sections 34 and 35 of RA 7160 otherwise known as the Local Government Code of 1991 provide and call for the meaningful participation of qualified organizations and associations in the pursuit of local autonomy and furtherance of development, and institutionalize their participation through the local special bodies;

WHEREAS, the San Pablo Small Water Impounding System Irrigators Association, Inc. has participated and got involved with the different programs and projects of the municipality;

WHEREAS, the San Pablo Small Water Impounding System Irrigators Association, Inc. is a centuries-old trade of the San Nicolas which has been a source of livelihood and now part of its heritage.

WHEREAS, after a thorough scrutiny on the background of the organization, the August Body, through the Committee on Agriculture and Cooperatives and Committee on Laws, Rules, Ethics, Privileges and Good Government, have found out that the San Pablo Small Water Impounding System Irrigators Association, Inc. has met all the requirements for reaccreditation;

WHEREAS, pursuant to Section 108 of RA 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Bayan is empowered to accredit the San Pablo Small Water Impounding System Irrigators Association, Inc. subject to such criteria as may be provided by law;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to reaccredit the San Pablo Small Water Impounding System Irrigators Association, Inc. as a Civil Society Organization Operating in the Municipality of San Nicolas, Province of Ilocos Norte;

RESOLVED FUTHER, to furnish copy of this Resolution to the San Pablo Small Water Impounding System Irrigators Association, Inc. and all concerned, for their information and guidance.


On motion of Member Angel Miguel L. Hernando, duly seconded, the foregoing resolution was unanimously approved.
