WHEREAS, Sections 34 and 35 of RA 7160 otherwise known as the Local Government Code of 1991 provide and call for the meaningful participation of gualified organizations and associations in the pursuit of local autonomy and furtherance of development, and institutionalize their participation through the local special bodies;

WHEREAS, the Brgy. 20 San Pablo Farmers Association, Inc. has participated and got involved with the different programs and projects of the municipality;

WHEREAS, the Brgy. 20 San Pablo Farmers Association, Inc. is a centuries-old trade of the San Nicolas which has been a source of livelihood and now part of its heritage.
