**WHEREAS**, the San Nicolas BIN-I Foundation, Inc. has participated and got involved with the different programs and projects of the municipality;

**WHEREAS**, the San Nicolas BIN-I Foundation, Inc. is a centuries-old trade of the San Nicolas which has been a source of livelihood and now part of its heritage.

**WHEREAS**, after a thorough scrutiny on the background of the organization, the August Body, through the Committee on Agriculture and Cooperatives and Committee on Laws, Rules, Ethics, Privileges and Good Government, have found out that the San Nicolas BIN-I Foundation, Inc. has met all the requirements for reaccreditation;


On motion of Member Moera Joy N. Galing-Luna, duly seconded, the foregoing resolution was unanimously approved.
