## **"MUNICIPAL ORDINANCE NO. 2019-12**

### AN ORDINANCE ADOPTING/APPROVING THE LIST OF PROGRAMS, PROJECTS AND ACTIVITIES WHICH WILL BE CHARGEABLE UNDER THE SHARE OF THE MUNICIPALITY FROM TOBACCO EXCISE TAX (RA 7171).

**WHEREAS**, pursuant to RA 7171, the Municipality of San Nicolas, Ilocos Norte has a share in the excise tax collected with a total amount of P10,555,363.00;

WHEREAS, Local Budget Memorandum No. 79, Series of 2019 and recent jurisprudence provide guidelines on the release and utilization of the shares of Local Government Units (LGUs) from the Collections of Excise Tax on Locally Manufactured Virginia-Type Cigarettes Under Republic Act (RA) No. 7171, chargeable against the allocations to LGUs under the FY 2018 General Appropriation Act (GAA), Republic Act No. 10964 and continuing appropriations;

**WHEREAS**, the list of programs, projects and activities are developmental and will benefit the twenty four (24) barangays in the municipality;

**WHEREAS,** to fully implement the same and to substantially comply with the rules and regulations on accounting and auditing of government projects using public funds, a list of identified programs, projects and activities are prepared for consideration;

## NOW, THEREFORE, BE IT ORDAINED THAT:

**SECTION 1.** There is an available fund amount to P10,555,363.00 from the proceeds of RA 7171.
