**WHEREAS**, the provisions of Rule XVIII, Art. 119 of the Rules Implementing the Local Government Code of 1991, requires that the appointment of heads of departments by the Mayor including the position of Municipal Civil Registrar must be concurred by the majority of all the Sangguniang Bayan Members, subject to the Civil Service Laws, Rules and Regulations;

**WHEREAS**, the position of Municipal Civil Registrar has been vacated due to the retirement of Ms. Fely Barayuga, the former OIC Municipal Civil Registrar;

**WHEREAS**, on September 2, 2019, MRS. ROSEMARIE B. ANTOLIN was appointed by the Municipal Mayor as the new Municipal Civil Registrar after consideration of her qualifications as prescribed by existing laws and the Civil Service Commission's rules and regulations;

**WHEREAS, MRS. ROSEMARIE B. ANTOLIN** having found to possess the minimum qualifications required for the position of Municipal Civil Registrar the Sangguniang Bayan hereby concurs with her appointment made by the Local Chief Executive;

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to concur/confirm as the Sangguniang Bayan hereby concurs to confirm the appointment of Mrs. Rosemarie B. Antolin as the Municipal Civil Registrar of San Nicolas, Province of Ilocos Norte.


On motion of Member Luciano R. Caraang, duly seconded, the foregoing resolution was unanimously approved.
