“RESOLUTION NO. 2019-272

A RESOLUTION URGING THE LOCAL CHIEF EXECUTIVE, HONORABLE ALFREDO P. VALDEZ, JR. TO TAKE THE NECESSARY ADMINISTRATIVE/LEGAL STEPS TO FINALLY PUT AN END AND RESOLUTION TO THE DISPUTE BETWEEN THE HEIRS OF AMBROCIA BATANGAN AND DR. BIENVENIDO ROMERO ALL RESIDENTS OF BRGY. 19, SAN LORENZO, SAN NICOLAS, ILOCOS NORTE.

WHEREAS, there has been a long unresolved dispute among some residents at Brgay. 19, San Lorenzo, San Nicolas, Ilocos Norte where the Barangay Government, including the Municipality and the Department of Environment and Natural Resources have intervened to possibly settle the matter amicably, but to no avail;

WHEREAS, the case stemmed on the leaning/falling fence and tree/s at the boundary of property lines of the Heirs of Ambrocia Batangan and Dr. Bienvenido Romero which the residents near Dr. Romero’s estate claim may collapse or fall anytime, to the detriment of their properties or worse may cause undue injury or harm to their limbs and lives;

WHEREAS, Dr. Bienvenido Romero refuses to abide by the order of the DENR as well as the plea of the folks nearby the area, to cause the cutting of the leaning tree and the demolition/repair of the fence;

WHEREAS, the Local Government Code and the Civil Code specifically provides the abatement of nuisances, the power being lodged at the Executive Branch of the Local Government Unit;

WHEREAS, the Sangguniang Bayan is of the belief that laws shall be applied fairly and justly to all, and the Body deems it appropriate, in consideration of the surrounding circumstances, that the Local Chief Executive should act on this matter with dispatch and without undue delay;

WHEREFORE, be it **RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan in session to urge the Local Chief Executive to take the necessary administrative/legal steps to put an end to this dispute so as to maintain peace and harmony in the area;

RESOLVED FURTHER to transcribe a copy of this resolution and furnish same to the Office of the Mayor, Honorable Alfredo Valdez, Jr. for his information and appropriate action.
