“RESOLUTION NO. 2019-322

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A
MEMORANDUM OF AGREEMENT (MOA) WITH THE MARIANO MARCOS MEMORIAL
HOSPITAL AND MEDICAL CENTER (MMM&MC) FOR THE IMPLEMENTATION OF THE
FINANCIAL/MEDICAL ASSISTANCE PROGRAM FOR INDIGENT/POOR/NEEDY PATIENTS AND
DATA SHARING.**

WHEREAS, Article XIII, Section 11 of the 1987 Philippine Constitution stipulates that “The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential good, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the under-privileged, sick, elderly, disabled, women, and children. The state shall endeavor to provide free medical care to paupers;

WHEREAS, Section 16 (General Welfare) of Republic Act 7160 otherwise known as the Local Government Code of 1991 expressly provides for every Local Government Unit to ensure and promote health and safety and enhance the right of the people to a balanced ecology and preserve the comfort and convenience of their inhabitants;

WHEREAS, the Local Government Unit is mandated to provide health services which include the implementation of programs and projects on primary health care, maternal and child care, and non-communicable disease control services;

WHEREAS, there is an existing balance in the fund allotted for the Trust Fund which can be utilized as financial/medical assistance intended for the indigent/poor/needy patients of the municipality;

WHEREAS, the Local Government Unit ensures to abide with the rules and standards promulgated by Data Privacy Act of 2012 and its IRR requirements regarding the transmission/provision of identifiable information.

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter Into a Memorandum of Agreement (MOA) with the Mariano Marcos Memorial Hospital and Medical Center (MMM&MC) for the Implementation of the Financial/Medical Assistance Program for Indigent/Poor/Needy Patients and Data Sharing.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;


On motion of Member Moera Joy N. Galing-Luna, duly seconded, foregoing resolution was unanimously approved.
