MANDAP, OIC-DIRECTOR IV, DBM REGION I, FOR THE POSSIBLE FUNDING OF THE PROPOSED INSTALLATION OF STREET LIGHTING SYSTEM (INSTALLATION OF 100 WATTS INTEGRATED SOLAR LIGHTS TO TWENTY-FOUR (24) BARANGAYS) SAN NICOLAS, ILOCOS NORTE.**

**WHEREAS**, the Local Government Unit of San Nicolas, Ilocos Norte has included in its plans and programs the installation of Street Lighting System in the twenty four barangays in the municipality marked as priority as these are deemed immediate needs of the municipality;

**WHEREAS**, one of the requirements set forth to avail of such program is a Sangguniang Bayan Resolution endorsing the said project to the concerned national agencies, thus, it WAS;

**RESOLVED** as it was hereby **RESOLVED BY THE** Sangguniang Bayan assembled in session to endorse the aforementioned project to the Office of the Honorable Wendel E. Avisado, Secretary of the Department of Budget and Management, thru, Ms. Estrella E. Mandap, OIC-Director IV, DBM Region I for the Proposed Project Identified by the LGU of San Nicolas, Ilocos Norte.

On motion of Member Jessie Julito P. Pumaras, Sr., duly seconded, the foregoing resolution was unanimously approved.




