“RESOLUTION NO. 2019-330

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A LICENSE OF AGREEMENT WITH THE PHILIPPINE NUCLEAR RESEARCH INSTITUTE – NUCLEAR SERVICE DIVISION FOR THE APPLICATION OF LICENSE TO OPERATE AN X-RAY FACILITY.

WHEREAS, the municipality recognizes that the Philippine Nuclear Research Institute is the owner of OSL Dosimeters, each unit consisting of an OSL card and card holder, which are available for use to monitor personnel who are occupationally exposed to radiation, the issuance of such units forming part of the personnel monitoring service rendered by PNRI for radiation protection purposes;

WHEREAS, the LGU desires to avail of such personnel monitoring service and, hence, the use of the PNRI OSL Dosimeter unit described above in connection with the LGU’s duly licensed use and/or handling of radioactive materials and/or radiation sources;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. –
xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter Into a License of Agreement with the Philippine Nuclear Research Institute – Nuclear Service Division for the Application of License to Operate an X-Ray Facility.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;


On motion of Member Moera Joy N. Galing-Luna, duly seconded, foregoing resolution was unanimously approved.
