“RESOLUTION NO. 2019-362

A RESOLUTION ADOPTING THE LOCAL PEACE AND ORDER AND PUBLIC SAFETY PLAN OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE FOR CALENDAR YEAR 2020-2022.

WHEREAS, one of the guideposts and main thrusts of the National Government is the promotion and maintenance of a peaceful, orderly and safe community;

WHEREAS, pursuant to Section 116 of Republic Act No. 7160, otherwise known as the “Local Government Code of 1991”, and Executive Order No. 773, Series of 2009, calls for the functionality of the Peace and Order Council, in which mandated to formulate a Peace and Order and Public Safety Plan (POPS Plan);

WHEREAS, the POPS Plan is a three (3) year term based plan which shall be incorporated in the Comprehensive Development Plan (CDP) of the municipal government and shall be approved by the Peace and Order Council and Adopted by the Sangguniang Bayan, aims to ensure social protection and public safety in the communities;

WHEREAS, DILG Memorandum Circular No. 2015-128, entitled Guidelines on the Formulation of Peace and Order and Public Safety Plan, was issued to guide Municipal Peace and Order Council (MPOC) in crafting of their POPS Plan;

WHEREAS, to sustain this policy, a Local Peace and Order and Public Safety Plan has been formulated thru the collaboration of various Civil Society Organization and National Agencies;

WHEREAS, the said plan was submitted to the Sangguniang Bayan for further study and scrutiny and after a comprehensive deliberation, it was found out that the Local Peace and Order and Public Safety Plan fits to the priorities of the Local Government Unit in so far as the promotion and maintenance of a peaceful, orderly, and safe community;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the Sangguniang Bayan assembled in session to adopt as it hereby adopts the Local Peace and Order and Public Safety Plan of the Municipality of San Nicolas, Province of Ilocos Norte;

RESOLVED FURTHER to transcribe copies of this resolution and furnish same to all concerned offices and departments for their information and appropriate action.


