“RESOLUTION NO. 2019-378

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE ROMAN CATHOLIC DIOCESE OF LAOAG RELATIVE TO THE PRESERVATION AND CONSERVATION OF ARCHIVES RECORDS AND DOCUMENTS RELATING TO SAN NICOLAS, ILOCOS NORTE.

WHEREAS, the Roman Catholic Diocese of Laoag and the municipality understand the value and significance of archives, considered to be as authentic evidence of human actions and valuable references in enriching the history of the municipality and the nation as general;

WHEREAS, UNESCO Universal Declaration on Archives states that “Archives are unique and irreplaceable heritage passed from one generation to another. Archives are managed from creation to preserve their value and meaning. They are authoritative sources of information underpinning accountable and transparent administrative actions. They play an essential role in the development of societies by safeguarding and contributing to individual, and community memory. Open access to archives enriches our knowledge of human society, promotes democracy, and protects citizen’s rights and enhance the quality of life.”;

WHEREAS, inspired by Presidential Proclamation No. 863, Series of 2019 issued on November 22, 2019 which declared Thursday, 26, 2019, a special (non-working) day in the Municipality of San Nicolas, Province of Ilocos Norte in celebration of the Damili Festival, this occasion is a fitting time for the Municipality and the Diocese of Laoag to collaborate and work together in conserving movable and intangible cultural heritages through a specific undertaking that will impact human values and development;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter Into a Memorandum of Understanding (MOU) with the Roman Catholic Diocese of Laoag Relative to the Preservation and Conservation of Archives Records and Documents Relating to San Nicolas, Ilocos Norte;

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;


On motion of Member Moera Joy N. Galing-Luna, duly seconded, foregoing resolution was unanimously approved.
