"RESOLUTION NO. 2020-55

A RESOLUTION ADOPTING PRESIDENTIAL PROCLAMATION NO. 124 DECLARING THE MONTH OF JANUARY OF EVERY YEAR AS NATIONAL BIBLE MONTH CULMINATING IN THE LAST WEEK THEREOF AS NATIONAL BIBLE WEEK.

WHEREAS, President Rodrigo Roa Duterte issued on January 5, 2020 Proclamation No. 124 declaring the month of January of every year as "National Bible Month", culminating in the last week thereof as National Bible Week;

WHEREAS, the Municipality of San Nicolas, Ilocos Norte has adopted as a matter of policy the Moral Recovery Program in its 9-Point Agenda which like Proclamation No. 124 intends to strengthen the spiritual values and to develop the moral character of the people;

WHEREAS, a component of the Moral Recovery endeavor of the Local Government Unit is the "Healing Time Program" which is primarily aimed to reform those involved in the drug menace and bring them back to the fold of community for them to become responsible citizens to help in community development;

WHEREAS, in coming up with a Presidential Proclamation encouraging the reading of the Bible would be of great help as the Bible remains to be the source of religious and spiritual teachings, the recovery and strengthening of the belief of the faithful and thus it is deemed proper and appropriate by the Sangguniang Bayan to adopt said Proclamation No. 124;

WHEREFORE, be it **RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session to adopt Presidential Proclamation No. 124 and encourage the involvement of all religious sects in the municipality;

RESOLVED FURTHER to transcribe copies of this resolution and furnish same to all offices of the LGU, National Agencies stationed in the municipality as well as those in the religious sector;
