"MUNICIPAL ORDINANCE NO. 2020-08

AN ORDINANCE ALLOWING THE EXTENSION OF THE TIME OF PAYMENT OF BUSINESS TAXES, FEES AND CHARGES FOR THE SECOND QUARTER OF THE CURRENT YEAR, FROM APRIL 21, 2020 TO JUNE 20, 2020 WITHOUT SURCHARGES OR PENALTIES.

WHEREAS, Section 15 Article II of the Philippine Constitution, provides that: It is the policy of the State to protect and promote the right to health of the people;

WHEREAS, Presidential Proclamation No. 922, Series of 2020 was issued declaring a State of Public Health Emergency throughout the Philippines due to Corona Virus Disease 2019 (COVID-19), enjoining all government agencies and local government units (LGUs) to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the threat of COVID-19;

WHEREAS, the payment of all business taxes, fees and charges for the second quarter of the current year is fixed on the 21st day of April, and failure on the part of the taxpayer would result in the payment of surcharges as may be provided by the Local Tax Code;

WHEREAS, pursuant to Art. 255, IRR, LGC 1991, the Sangguniang Bayan may, for justifiable reason or cause, extend the time of payment of such taxes, fees or charges without surcharges or penalties;

WHEREAS, there is a pressing need to extend the time of payment in consideration to ill effects of the dreaded Corona Virus Disease 2019 Pandemic:

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN SESSION DULY ASSEMBLED THAT:

SECTION 1. *Title.* - This ordinance shall be known as an "Ordinance Allowing the Extension of the Time of Payments of Business Taxes, Fees, and Charges for Second Quarter from April 21, 2020 to June 20, 2020 without surcharges or penalties".





SECTION 2. *Extension.* - The time of payments of business taxes, fees and charges for second quarter is hereby extended from April 21, 2020 to June 20, 2020 without the imposition of surcharges, interest or other penalties.

SECTION 3. Applpicability Clause. This ordinance shall apply to those business establishments who chose to pay their annual taxes on a quarterly basis.

SECTION 4. Effectivity. This ordinance shall take effect upon approval.
