**“RESOLUTION NO. 2020-186**

**A RESOLUTION AUTHORIZING THE USE OF THE UNEXPENDED BALANCES FROM THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR THE YEARS 2017, 2018 and 2019 AMOUNTING TO EIGHT MILLION SIX HUNDRED SEVENTY FOUR THOUSAND SEVEN HUNDRED FORTY THREE PESOS AND 98/100 (P8,674,743.98) TO ADDRESS THE BASIC NEEDS OF THE TOWNSPEOPLE AND OTHER PROGRAMS OF THE MUNICIPALITY IN MITIGATING THE SEVERE EFFECTS OF THE PANDEMIC COVID-19.**

**WHEREAS**, the Municipality of San Nicolas has available Savings from the DRMM Fund from Calendar Years 2017, 2018 and 2019 now in the Trust Fund amounting to Eight Million Six Hundred Seventy Four Thousand Seven Hundred Forty Three Pesos and 98/100 (P8,674,743.98);

**WHEREAS**, the Quick Response Fund (QRF) which is 30% of the 2020 DRRM Fund and the 2015 and 2016 savings from the DRRM had already been exhausted in addressing the immediate and basic needs of the townspeople as well as the front-liners and Health Workers brought about by the pandemic and dreadful COVID-19;

**WHEREAS**, there is a compelling need to augment such funds to at least sustain the needs of the citizens, as the situation remains uncertain and the people are still forced to stay in their homes to avoid the transmission of the deadly virus;

**WHEREAS**, the utilization of the Trust fund shall be subject to existing accounting and auditing rules and guidelines.

**WHEREAS**, the Sangguniang Bayan concurred to authorize the utilization of the unexpended balances from the LDRRM Fund for the years 2017, 2018 and 2019 amounting to Eight Million Six Hundred Seventy Four Thousand Seven Hundred Forty Three Pesos and 98/100 (P8,674,743.98) to fund the following PPA:

1. Financial Assistance to Affected Families P8,674,743.98

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN IN SESSION**, to authorize the use of the Trust Fund of the municipality specifically the savings from the LDRRM Fund in the years 2017, 2018 and 2019 amounting to Eight Million Six Hundred Seventy Four Thousand Seven Hundred Forty Three Pesos and 98/100 (P8,674,743.98) to be given as Financial Assistance to affected families

consistent with the recommendation of the Municipal Disaster Risk Reduction and Management Council (MDRRMC);

**RESOLVED FURTHER** to transcribe copies of this resolution and furnish the same to the Local Chief Executive and to all concerned, for their reference and guidance.


On motion of Member Luciano R. Caraang, duly seconded, the foregoing resolution was unanimously approved.
