“MUNICIPAL ORDINANCE NO. 2020-09

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1 OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE IN THE AMOUNT OF NINE MILLION THREE HUNDRED FORTY SEVEN THOUSAND TWO HUNDRED EIGHT PESOS (P9,347,208.00) FROM THE BAYANIHAN GRANT TO CITIES/MUNICIPALITIES (BGCM) FOR COVID-19 RELATED PPAs.

WHEREAS, pursuant to Supplemental Budget No. 1 for Fiscal Year 2020, there exists a fund/special account under the general fund amounting to Nine Million Three Hundred Forty Seven Thousand Two Hundred Eight Pesos (P9,347,208.00) from the Bayanihan Grant to Cities and Municipalities (BGCM);

WHEREAS, the available funds are hereunder appropriated for the various PPAs of the municipality, in accordance with Local Budget Circular No. 125 of the DBM;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan in session duly assembled that:

SECTION 1. There exists an amount of P9,347,208.00 from the BGCM intended to mitigate the effects of COVID19;

SECTION 2. Pursuant to Local Budget Circular No. 125, Department/s concerned are hereby directed to create a Special Account in the General Fund (SAGF) pursuant to Section 313 of RA 7160 for the effective implementation of the various PPAs;

SECTION 3. Appropriation of Funds. The amount of **P9,347,208.00** shall be appropriated as follows:


SECTION 4. Effectivity. - This ordinance shall take effect upon approval.
