"MUNICIPAL ORDINANCE NO. 2020-12

AN ORDINANCE REGULATING THE OPERATION OF TRICYCLES-FOR-HIRE WITHIN THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE DURING THE COVID-19 PANDEMIC AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

BE IT ORDAINED THAT:

SECTION 1. *Short Title.* This ordinance shall be known as the "Operation of Tricycles-For-Hire in the municipality during the COVID-19 Pandemic".

SECTION 2. *Coverage.* All tricycles-for-hire in the Municipality of San Nicolas, Province of Ilocos Norte that have complied with the requirements in the operation of tricycles as provided by Tricycle Code of the LGU.

SECTION 3. *Terminals.* The following areas would be used as temporary terminals for tricycles allowed to operate during the duration of the COVID-19 pandemic.

- 1. Existing Terminal Infront of 711;
- 2. Existing Terminal beside the Public Plaza;
- 3. Existing Terminal at the Valdez Center, and
- 4. North of the Roman Catholic Church.

SECTION 4. *Schedule of operation.* The following schedule of operation of tricycles shall be observed.

- a. Tricycles whose sidecar numbers end with an odd number shall be allowed to operate on odd number dates of the calendar, during the duration of the GCQ.
- b. Tricycles whose sidecar numbers end with an even number shall be allowed to operate on even number dates of the calendar, during the duration of the GCQ.

SECTION 5. *Prohibited Acts.*

- a. Those with expired driver's license and Certificate of Registration prior to the issuance of Proclamation Order No. 922, Declaring a State of Public Health Emergency throughout the Philippines, shall not be allowed to operate;
- b. Those with expired Franchise or MTOP prior to the issuance of Proclamation Order No. 922, Declaring a State of Public Health Emergency throughout the Philippines, shall also be prohibited to operate;
- c. Those with licenses which expired during the duration of the COVID-19 Pandemic are allowed to operate subject to the guidelines issued by the Department of Transportation (DOTR), the Land Transportation Office (LTO) and other concerned agencies.

SECTION 5. Other regulations.

- a. Tricycle Drivers shall at all times wear face mask and gloves during their operation.
- b. Only one (1) passenger is allowed;
- c. A shield between the passenger and the driver must also be provided by the operator/driver.
- d. The fare rate as provided by Municipal Ordinance No. 2018-15 shall remain in full force and effect.

SECTION 5. *Penal Provisions.*

- a. Any individual who violates the ordinance will render community service for seven (7) days.
- b. For the second offense, the violator will be fined in the amount of One Thousand (P1,000.00) and community service for ten (10) days.
- c. Third or multiple offense the violator will be fined P2,500.00 or imprisonment of one (1) month, or both upon the discretion of the court.

SECTION 6. *Separability Clause.* If for any reason or reasons, a part or provision of this ordinance is declared contrary to law, morals, public order or public policy, all other provisions shall remain valid and effective.

SECTION 7. *Effectivity.* This ordinance shall take effect upon approval and shall be effective during the entire duration of the GCQ/MGCQ.
