“MUNICIPAL ORDINANCE NO. 2020-13

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 2 FOR FISCAL YEAR 2020 FROM THE PERSONAL SERVICES SAVINGS (VACANT POSITIONS JANUARY TO APRIL) AMOUNTING TO TWO MILLION TWO HUNDRED FIFTY THREE THOUSAND SEVEN HUNDRED THIRTY SEVEN PESOS AND 85/100 (P2,253,737.85) AND APPROPRIATING THE AMOUNT OF TWO MILLION TWO HUNDRED FORTY THREE THOUSAND SEVENTY PESOS AND 96/100 (P2,243,070.96) FOR THE GRANT OF COVID-19 HAZARD PAY AND SPECIAL RISK ALLOWANCE TO ALL QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, pursuant to Supplemental Budget No. 2 for Fiscal Year 2020, there exists a personal services savings (vacant positions January to April) amounting to Two Million Two Hundred Fifty Three Thousand Seven Hundred Thirty Seven Pesos and 85/100 (P2,253,737.85) for the grant of COVID-19 hazard pay and special risk allowance to all qualified municipal officials and employees of the Municipality of San Nicolas, Ilocos Norte;

WHEREAS, the available funds are hereunder appropriated for the grant of COVID-19 hazard pay and special risk allowance to all qualified municipal officials and employees of the municipality as provided for under DBM Budget Circular Nos. 2020-1 dated March 24, 2020 and 2020-2 dated April 7, 2020 respectively;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan in session duly assembled that:

SECTION 1. There is an existing personal services savings (vacant positions January to April) in the amount of **P2,253,737.85**.

SECTION 2. The amount of **P2,243,070.96** shall be appropriated as follows:


