"RESOLUTION NO. 2020-189

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PROVINCIAL GOVERNMENT OF ILOCOS NORTE AND RESIDENTS OF SAN NICOLAS, ILOCOS NORTE INCLUDING REPATRIATED OFWS/EXCHANGE STUDENTS, FOR THEM TO BE ALLOWED ENTRY IN THE PROVINCE IN THIS TIME OF ENHANCED COMMUNITY QUARANTINE OVER LUZON AND TOTAL LOCKDOWN IN ILOCOS NORTE DUE TO COVID-19 PANDEMIC.

WHEREAS, on March 29, 2020, the Province of Ilocos Norte was placed under a total lockdown through Executive Order No. 65-20 due to Corona Virus Infectious Disease 2019, disallowing the entry of people and non-essential cargoes in the province;

WHEREAS, however, there are some people stranded at the borders who claim to be residents of llocos Norte;

WHEREAS, a resident is one among those stranded and has no other alternative residence elsewhere and who desires to be allowed entry to the province, to which PGIN agrees upon the warranties of the LGU, under the terms prescribed in the MOA;

WHEREAS, the Sangguniang Bayan after due consideration, is satisfied that the said measure is for the interest of the public health and service as well as the returning resident;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

Page 2, Resolution No. 2020-189;

WHEREAS, the Municipal Mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. -xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter Into a Memorandum of Agreement (MOA) with the Provincial Government Of Ilocos Norte And Residents Of San Nicolas, Ilocos Norte Including Repatriated OFWs/Exchange Students, for them to be allowed entry in the Province in this time of Enhanced Community Quarantine Over Luzon and Total Lockdown in Ilocos Norte Due to COVID-19 Pandemic.

RESOLVED, FURTHER, that copies of this Resolution be furnished the Honorable Mayor and all concerned national government agencies, for their information.

On motion of Member Angel Miguel L. Hernando, duly seconded, foregoing resolution was unanimously approved.
