“RESOLUTION NO. 2020-198

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF EDUCATION (DEPED) REGIONAL OFFICE REGARDING THE USE OF IDENTIFIED CLASSROOMS IN CERTAIN SCHOOLS IN THE MUNICIPALITY AS QUARANTINE OR ISOLATION AREAS FOR COVID-19 CASES.

WHEREAS, President Rodrigo Roa Duterte issued Proclamation No. 922 dated March 8, 2020, “Declaring a State of Public Health Emergency Throughout the Philippines”, in view of the COVID-19 outbreak”;

WHEREAS, Section 2 of Proclamation No. 922, Series of 2020 stats that, “(a) All government agencies and LGUs are hereby enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the COVID-19 threat”;

WHEREAS, the LGU needs a facility for quarantine or isolation area relative to its response to the COVID-19 public health emergency and it has no other available place or structure for use, thus it submitted a request to the RO for the use of the different schools in the municipality, that meets the standards of the DOH;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the Municipal Mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter Into a Memorandum of Agreement (MOA) with the Department of Education (DEPED) Regional Office regarding the identified Classrooms in Certain Schools in the Municipality as Quarantine or Isolation Areas for COVID-19 Cases.

RESOLVED, FURTHER, that copies of this Resolution be furnished the Honorable Mayor and all concerned national government agencies, for their information.


On motion of Member Moera Joy N. Galing-Luna, duly seconded, foregoing resolution was unanimously approved.
