“MUNICIPAL ORDINANCE NO. 2020-14

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 3 FOR FISCAL YEAR 2020 FROM THE RETAINED EARNINGS AMOUNTING TO THIRTY FIVE MILLION FOUR HUNDRED THREE THOUSAND SIX HUNDRED SEVENTY AND 66/100 PESOS (P35,403,670.66) AND APPROPRIATING THE SAME FOR VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES OF THE MUNICIPALITY AND FOR THE GRANT OF TERMINAL LEAVE BENEFITS TO QUALIFIED MUNICIPAL EMPLOYEE/S.

WHEREAS, pursuant to Supplemental Budget No. 3 for Fiscal Year 2020, there exists a retained earnings amounting to Thirty Five Million Four Hundred Three Thousand Six Hundred Seventy and 66/100 Pesos (P35,403,670.66) for various programs, projects and activities of the municipality and for the grant of terminal leave benefits to qualified municipal employee/s;

WHEREAS, the available funds are hereunder appropriated for various programs, projects and activities of the municipality and for the grant of terminal leave benefits to qualified municipal employee/s;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan in session duly assembled that:

SECTION 1. There is an existing retained earnings of the municipality in the amount of **P35,403,670.66**.
