"RESOLUTION NO. 2020-264"

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MARIANO MARCOS STATE UNIVERSITY (MMSU) AND THE DEPARTMENT OF INFORMATION AND COMMUNICATION TECHNOLOGY (DICT) FOR THE SETTING UP OF LEARNING SPACES IN THE LOCALITY WHERE STUDENTS FROM MMSU AND OTHER SCHOOLS CAN CONVERGE TO ACCESS ONLINE RESOURCES.

WHEREAS, the emergence of COVID-19 Pandemic in the world has caused a Global Crisis to the entire populace imposing limitation to mobility and the need for social distancing;

WHEREAS, COVID-19 Pandemic has compelled State Universities and Colleges (SUCs) and Higher Education Institutions (HEIs) like MSSU to recalibrate instruction delivery whereby traditional face-to-face classroom learning is replaced by flexible learning arrangements;

WHEREAS, the flexible learning arrangement necessitates SUCs and HEIs to engage in collaborative efforts with Local Government Units, other Government Agencies and Private Sectors to converge their resources for the delivery of quality learning alternatives;

WHEREAS, MMSU has initiated "MMSU-LGU-TELCO Converge for Virtual Learning Project" embodying the tripartite convergence of MMSU, Local Government Units, other Government Agencies and Private Sectors to ensure that no student is left behind in this "New Normal".

WHEREAS, 5.67% of the total population of students enrolled during the second semester 2019-2020 in the University are from the Municipality of San Nicolas";

WHEREAS, the Municipality of San Nicolas has agreed to provide for "Learning Hubs", containing computer units, printing stations, Free-Wifi Stations accessible to MMSU students to do online admission, enrollment, orientation and on line learning;

WHEREAS, this Honorable August Body after due consideration and satisfied that the said measure is for the interest of the public service and would enhance the immediate delivery of basic services to our affected people, is convinced of the merit and wisdom of the purpose of which authority is hereby sought by the Honorable Mayor.

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:



Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

XXX XXX XXX

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

- (b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:
- (vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance."

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter Into a Memorandum of Agreement (MOA) with the Mariano Marcos State University (MMSU) and the Department of Information and Communication Technology (DICT) for the Setting Up of Learning Spaces in the Locality Where Students from MMSU and other Schools Can Converge to Access Online Resources.

RESOLVED, FURTHER, that copies of this Resolution be furnished the Honorable Mayor and all concerned national government agencies, for their information.
