**A RESOLUTION ADOPTING/APPROVING THE PROPOSED PROGRAMS/PROJECTS/ACTIVITIES TO BE FUNDED OUT OF THE 20% DEVELOPMENT FUND OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE FOR CALENDAR YEAR 2021 AS EMBODIED IN THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2020-04.**

**WHEREAS**, the municipality is expecting the amount of One Hundred Twenty Million Two Hundred Sixteen Thousand Four Hundred Twelve Pesos (P120,216,412.00) as its Internal Revenue Allotment (IRA) share for the year 2021;

**WHEREAS**, 20% of the total IRA amounting to Twenty Four Million Forty Three Thousand Two Hundred Eighty Two and 40/100 Pesos (P24,043,282.40) is set aside as the Development Fund of the municipality;
