“RESOLUTION NO. 2020-312

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MARIANO MARCOS STATE UNIVERSITY, BATAK CITY IN CONNECTION WITH THE CONDUCT OF SCHOOL ON THE AIR (SOA) PROGRAM DUBBED AS ISKWELA ITI TANGATANG, TARABAY ITI PAGBIAGAN, SALUN-AT (TIPPS), KEN DADDUMA PAY.

WHEREAS, MMSU through its Extension Directorate endeavors to disseminate and promote the utilization of developmental information and technologies among the public through deliberate, effective and efficient ways in partnership with other development agencies, local government units, and people's organizations to achieve its mission and vision by way of conducting the School on-the-Air/Iskwela iti Tangatang;

WHEREAS, the Municipal Government of San Nicolas cooperates and coordinates with other agencies of government and private institutions to carry-out a more effective and efficient delivery of development services to its area of jurisdiction and to the people herein;

WHEREAS, the emergence of COVID-19 Pandemic in the world has greatly affected the mobility populace;

WHEREAS, after due consideration, the Sangguniang Bayan finds that the said measure is for the interest of the public service and would enhance the immediate delivery of basic services to our affected people, is convinced of the merit and wisdom of the purpose of which authority is hereby sought by the Honorable Mayor.

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.

– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter Into a Memorandum of Agreement (MOA) with the Mariano Marcos State University, Batac City, in connection with the conduct of School on the Air (SOA) Program Dubbed as Iskwela iti Tangatang, Tarabay iti Pagbiagan, Salun-at (TIPPS), ken Dadduma Pay.

RESOLVED, FURTHER, that copies of this Resolution be furnished the Honorable Mayor and all concerned national government agencies, for their information.


On motion of Member Norberto D. Dadiz, Sr., duly seconded, foregoing resolution was unanimously approved.


