“MUNICIPAL ORDINANCE NO. 2020-30

AN ORDINANCE REVERTING THE AMOUNT OF THREE MILLION TWO HUNDRED FIFTEEN THOUSAND PESOS (P3,215,000.00) FROM THE MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) SAVINGS AS OF SEPTEMBER 30, 2020 AND APPROPRIATING THE SAME FOR THE GRANT OF COLLECTIVE NEGOTIATION AGREEMENT INCENTIVE AND GRATUITY PAY TO QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPALITY.

WHEREAS, there exists an available fund in the amount of Three Million Two Hundred Fifteen Thousand Pesos (P3,215,000.00) representing Maintenance and Other Operating Expenses (MOOE) Savings as of September 30, 2020;

WHEREAS, the amount of Three Million Two Hundred Fifteen Thousand Pesos (P3,215,000.00) is appropriated for the grant of CNA Incentive and Gratuity Pay to Qualified Municipal Officials and Employees of the municipality;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan duly assembled that:

SECTION 1. There is an available amount of Three Million Two Hundred Fifteen Thousand Pesos (P3,215,000.00) representing Maintenance and Other Operating Expenses (MOOE) Savings as of September 30, 2020;

SECTION 2. The amount of Three Million Two Hundred Fifteen Thousand Pesos (P3,215,000.00) from the Maintenance and Other Operating Expenses (MOOE) Savings as of September 30, 2020 is hereby reverted to the General Fund and shall be appropriated for the following, as follows:
