“MUNICIPAL ORDINANCE NO. 2020-31

AN ORDINANCE REVERTING THE AMOUNT OF ONE MILLION FOUR HUNDRED THOUSAND EIGHT HUNDRED SIXTY EIGHT PESOS AND TWENTY TWO CENTAVOS (P1,400,868.22) FROM THE PERSONAL SERVICES SAVINGS (MAY TO AUGUST 2020) TO THE GENERAL FUND AND APPROPRIATING THE SAME FOR THE PURCHASE OF PHOTOCOPIING MACHINE AND GRANT OF SERVICE RECOGNITION INCENTIVE (SRI) TO QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPALITY.

WHEREAS, there exists an available fund in the amount of One Million Four Hundred Thousand Eight Hundred Sixty Eight Pesos and Twenty Two Centavos (P1,400,868.22) representing Personal Services Savings (May to August 2020);

WHEREAS, the amount of One Million Four Hundred Thousand Eight Hundred Sixty Eight Pesos and Twenty Two Centavos (P1,400,868.22) shall be reverted to the General Fund and appropriated for the purchase of photocopying machine and grant of Service Recognition Incentive (SRI) to Qualified Municipal Officials and Employees of the municipality;

WHEREAS, the aforesaid savings from the Personal Services (May to August 2020) is allowed under Department of Budget and Management (DBM) Budget Circular No. 2020-6 dated December 22, 2020 where the One-Time Service Recognition Incentive (SRI) will come from;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan duly assembled that:

SECTION 1. There is an available amount of One Million Four Hundred Thousand Eight Hundred Sixty Eight Pesos and Twenty Two Centavos (P1,400,868.22) representing Personal Services Savings (May to August 2020);

SECTION 2. The amount of One Million Four Hundred Thousand Eight Hundred Sixty Eight Pesos and Twenty Two Centavos (P1,400,868.22) from the Personal Services Savings (May to August 2020) is hereby reverted to the General Fund and shall be appropriated for the following, as follows:
