“RESOLUTION NO. 2020-324

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE MARIANO MARCOS STATE UNIVERSITY TO ALLOW THEIR LIBRARIAN/LIBRARY PERSONNEL TO DIGITIZE THE ILOKANIANA COLLECTION ABOUT SAN NICOLAS HISTORY, PEOPLE, LITERATURE, CULTURE AND OTHERS.

WHEREAS, the MMSU and the Municipality of San Nicolas, Ilocos Norte, Municipal Library/iHub intend to jointly work together to explore ways to preserve and digitize information resources (print and non-print) of San Nicolas, Ilocos Norte – its history, cultural heritage, literature, folklore, Ilokano writings, and others.

WHEREAS, the Municipality of San Nicolas is a Local Government Unit that regularly support and implement culture and arts program for the benefit of its constituencies;

WHEREAS, the Municipality of San Nicolas can ensure and encourage the continuing and balanced development of culture by the people themselves;

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.
– xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter Into a Memorandum of Understanding (MOU) with the Mariano Marcos State University to allow their Librarian/Library Personnel to Digitize the Ilokianiana Collection about San Nicolas History, People, Literature, Culture and Others.

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Juanito P. Ulep, Jr., duly seconded, foregoing resolution was unanimously approved.
