### **“RESOLUTION NO. 2020-329**

#### **A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOCOS NORTE ELECTRIC COOPERATIVE, INC. FOR THE SALE OF ELECTRICITY.**

**WHEREAS**, the construction and establishment of the Engineered Sanitary Landfill of the Municipality of San Nicolas, Ilocos Norte is one of the core programs of the Local Government Unit which now caters garbage generated by the residents and commercial establishments of the town;

**WHEREAS**, there is a need to provide such huge landfill with adequate electric power for it to maximize its operation;

**WHEREAS**, the Ilocos Norte Electric Cooperative (INEC), a private corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines;

**WHEREAS**, the INEC is willing to sell and deliver power and energy to the LGU the specifications of which shall be contained in the appropriate contract or agreement;

**WHEREAS**, after due consideration, the Sangguniang Bayan finds that the said measure is for the interest of the public service and would enhance the operation of the Engineered Sanitary Landfill of the municipality, is convinced of the merit and wisdom of the purpose of which authority is hereby sought by the Honorable Mayor.

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

xxx

xxx

*(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.*

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

*Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.*  
– xxx

*(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:*

*(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”*

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

**RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter Into a Memorandum of Agreement (MOA) with the Ilocos Norte Electric Cooperative, Inc. for the Sale of Electricity.

**RESOLVED, FURTHER**, that copies of this Resolution be furnished the Honorable Mayor and all concerned national government agencies, for their information.

On motion of Member Juanito P. Ulep, Jr., duly seconded, foregoing resolution was unanimously approved.
