- 4) Barangay Appropriation Ordinance No. 2020-02 of Barangay 21, San Agustin entitled, “An Ordinance Authorizing the Annual Budget of Barangay 21, San Agustin, San Nicolas, Ilocos Norte for Calendar Year 2021 in the Total Amount of Three Million Four Hundred Ninety Two Thousand Nine Hundred Four Pesos (P3,492,904.00) Covering the Various Expenditures for the Operation of the Barangay Government of Barangay 21, San Agustin, San Nicolas, Ilocos Norte for the Period January One to December Thirty One, Two Thousand Twenty One, and for other purposes”.




