“MUNICIPAL ORDINANCE NO. 2021-06

AN ORDINANCE APPROPRIATING THE AMOUNT OF ELEVEN MILLION ONE HUNDRED SIXTY FIVE THOUSAND NINE HUNDRED FORTY THREE PESOS (P11,165,943.00) FOR PROGRAMS AND PROJECTS TO BE IMPLEMENTED BY THE LOCAL GOVERNMENT UNIT FROM THE FISCAL YEAR 2017 COLLECTION OF TOBACCO EXCISE TAX ON LOCALLY MANUFACTURED VIRGINIA-TYPE CIGARETTES PURSUANT TO REPUBLIC ACT NO. 7171 PER LOCAL BUDGET MEMORANDUM NO. 81.

WHEREAS, pursuant to RA 7171, the Municipality of San Nicolas, Ilocos Norte has a share in the tobacco excise tax collected with a total amount of P11,165,943.00;

WHEREAS, Local Budget Memorandum No. 81, Series of 2020 and recent jurisprudence provide guidelines on the release and utilization of the shares of Local Government Units (LGUs) from the Collections of Tobacco Excise Tax on Locally Manufactured Virginia-Type Cigarettes Under Republic Act (RA) No. 7171 and Burley and Native Tobacco Excise Tax Pursuant to Republic Act (RA) No. 8240 as amended by Republic Act (RA) No. 10351, chargeable against the allocations to LGUs under the FY 2019 General Appropriation Act (GAA), Republic Act No. 11260;

WHEREAS, to fully implement the same and to substantially comply with the rules and regulations on accounting and auditing of government projects using public funds, a list of identified programs, projects and activities were adopted/approved per Municipal Resolution No. 2020-330 for consideration;

NOW, THEREFORE, BE IT ORDAINED THAT:

SECTION 1. There is an available fund amounting to Eleven Million One Hundred Sixty Five Thousand Nine Hundred Forty Three Pesos (P11,165,943.00) from the proceeds of RA 7171.

SECTION 2. Appropriation. The amount of Eleven Million One Hundred Sixty Five Thousand Nine Hundred Forty Three Pesos (P11,165,943.00) shall be appropriated for the following, as follows:


SECTION 4. Effectivity. This ordinance shall take effect after complying with its posting and publication requirements as provided by the Local Government Code of 1991.
