**“MUNICIPAL ORDINANCE NO. 2021-08**

**AN ORDINANCE LIFTING THE NUMBER CODING SCHEME IN THE OPERATION OF TRICYCLES DURING THE PANDEMIC AS PROVIDED FOR IN MUNICIPAL ORDINANCE NO 2020-12, ENTITLED, “AN ORDINANCE REGULATING THE OPERATION OF TRICYCLES FOR HIRE WITHIN THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE DURING THE COVID-19 PANDEMIC AND PROVIDEING PENALTIES FOR VIOLATION THEREOF.**

**WHEREAS**, the operation of tricycles in the Municipality of San Nicolas during the prevalence of the COVID-19 pandemic is regulated thru the enactment of Municipal Ordinance 2020-12;

**WHEREAS**, Section 4 of the above-mentioned ordinance provides among others, the schedule of operation of tricycles granted a Motorized Tricycle Operator’s Permit (MTO), now commonly known as the “number coding” scheme;

**WHEREAS**, in consideration of the clamor of the majority of tricycle operators and drivers in the municipality to allow them again to ply their routes on a daily basis, coupled with the easing up of health protocols as recently announce by the IATF, the Sangguniang Bayan assembled in session, **RESOLVED**, to **ORDAIN THE FOREGOING**:

**SECTION 1. Short Title.** This ordinance shall be known as the “Ordinance lifting the Odd-Even Number Coding scheme in the operation of tricycles in the Municipality of San Nicolas”.

**SECTION 2. Lifting of the Number Coding Scheme.** Section 4 of Municipal Ordinance No. 2020-12 is hereby lifted, thus allowing all tricycles granted with an MTO and franchise to operate, to ply their usual routes on a daily basis.

**SECTION 3. Repealing Clause.** Any issuances, ordinances and regulations not consistent with this ordinance are hereby repealed accordingly. The remaining provisions of Municipal Ordinance No. 2020-12 shall remain to be in full force and effect.


**SECTION 4. Effectivity.** This ordinance shall take effect immediately upon approval.
