“MUNICIPAL ORDINANCE NO. 2021-11

AN ORDINANCE REVERTING THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) FROM THE FUND OF MPDP PROJECT (RA 7171 FUND 2016) SAMAC SMALL WATER IMPOUNDING SYSTEM IRRIGATORS ASSOCIATION (SWISIA) INC. AND APPROPRIATING THE SAME FOR THE GRANT OF BRGY. 19 SAN LORENZO TAMURONG FARMERS ASSOCIATION OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, pursuant to RA 7171, the Municipality of San Nicolas, Ilocos Norte has a share in the excise tax collected with a total amount of P10,555,363.00;

WHEREAS, Local Budget Memorandum No. 79, Series of 2019 and recent jurisprudence provide guidelines on the release and utilization of the shares of Local Government Units (LGUs) from the Collections of Excise Tax on Locally Manufactured Virginia-Type Cigarettes Under Republic Act (RA) No. 7171, chargeable against the allocations to LGUs under the FY 2018 General Appropriation Act (GAA), Republic Act No. 10964 and continuing appropriations;

WHEREAS, to fully implement the same and to substantially comply with the rules and regulations on accounting and auditing of government projects using public funds, a list of identified programs, projects and activities were adopted/approved per Municipal Ordinance No. 2019-12 for consideration;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan duly assembled that:

SECTION 1. There is an available amount of Five Hundred Thousand Pesos (P500, 000.00) representing Samac Small Water Impounding System Irrigators Association (SWISIA) Inc. from the proceeds of RA 7171;

SECTION 2. Appropriation. The amount of Five Hundred Thousand Pesos (P500,000.00) is hereby reverted and shall be appropriated as



SECTION 4. Effectivity. This ordinance shall take effect after complying with its posting and publication requirements as provided by the Local Government Code of 1991.


