“RESOLUTION NO. 2021-23

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MARIANO MARCOS MEMORIAL HOSPITAL AND MEDICAL CENTER (MMM&MC) TO PROVIDE TO PROVIDE LABORATORY AND X-RAY SERVICES THAT ARE NOT AVAILABLE IN THE MUNICIPAL HEALTH OFFICE.

WHEREAS, PhilHealth Circular No. 010, s2012 prescribing the Implementing Guidelines for Universal health Care Primary Care benefit (PCB1) Package for Transition Period CY 2012-2013 calls for the provision of Chest X-Ray (Section III.A.B.7) for all members under the Sponsored Program, Organized Groups and Overseas Workers Programs and their qualified dependents;

WHEREAS, the same is called for in the Primary Health Care Services as prescribed by PhilHealth Circular No. 002-2015, subject matter of which is the *Governing Policies on the Expanded Coverage of the Primary Care Benefit Package Tamang Serbisiyo sa Kalusuganng Pamilya (TSeKaP)*;

WHEREAS, the MHO of San Nicolas is a PCB1 & TB DOTS provider; however, in case of deficiency or inability by the San Nicolas Municipal Health Office to deliver required Laboratory and X-Ray services, hence the need to “. . . **forge a Memorandum of Agreement with another health facility to provide those diagnostic tests that are not available in their facility.**” (Par. 5, Section IV of PHIC Circular No. 010, s. 2012);

WHEREAS, the **MMM & MC**, an Infirmary Hospital and under the **FIRST PARTY**, is equipped and licensed to provide Laboratory and X-Ray procedures and therefore, can and are willing to provide said services;

WHEREAS, the parties must ensure the confidentiality of the records pertaining to the patients subject of this MOA through means/methods to protect their identity in compliance with the provision of Republic Act 10173, known as the Data Privacy Act of 2012.

NOW, THEREFORE, for and in consideration of the following premises, the herein parties have agreed and do hereby agree on the following:

THE FIRST PARTY, THRU THE MMMH & MC, PARTICULARLY THE RADIOLOGY & LABORATORY DEPARTMENT/SECTION shall:

1. Accept referrals for Laboratory and Chest X-Ray based on the duly accomplished Referral Form issued by the MHO of San Nicolas and presented by the entitled member/dependent;
2. Instruct the entitled member/dependent on the hospital protocols prior to the conduct/performance of the required Laboratory and Chest X-Ray;

- 3. Issue Charge Slip and perform the required procedure upon presentation of the Official Receipt;
- 4. Issue printed images upon the request of the RHU Physician.

THE SECOND PARTY shall:

- 1. Refer entitled member/dependent requiring Laboratory and Chest X-Ray to MMMH & MC;
- 2. Coordinate & facilitate such referral;
- 3. Provide the entitled member/dependent a Referral Form duly accomplished by the RHU Physician, with the instruction for the entitled member/dependent to present the same to the hospital of choice, that is MMMH & MC, including his/her updated MDR;
- 4. Pay immediately upon issuance of the Charge Slip, the corresponding fees based on the prevailing rates, as well as Professional Fees, prescribed in the Provincial Revenue Code/Tax Ordinance & its amendments;
- 5. Be allowed to borrow printed images based on the request of the RHU Physician, subject however that the same shall be returned immediately.

WHEREAS, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

xxx

(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

WHEREAS, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

RESOLVED as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter Into a Memorandum of Agreement (MOA) with the .

RESOLVED, FURTHER, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Moera Joy N. Galing-Luna, duly seconded, foregoing resolution was unanimously approved.


