### “RESOLUTION NO. 2021-25

**A RESOLUTION EARNESTLY REQUESTING THE HONORABLE ANDREA D. DOMINGO, CHAIRMAN AND CHIEF EXECUTIVE OFFICER OF THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) TO PROVIDE FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED MILLION PESOS (P100,000,000.00) FOR THE CONSTRUCTION OF AN EVACUATION CENTER OR MULTI-PURPOSE BUILDING IN THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE.**

**WHEREAS**, Section 17, (Basic Services and Facilities) paragraphs a and b, section (1), sub-section (vi) of RA 7160 otherwise known as the Local Government Code of 1991 expressly provides that:

*“Local Government Units shall exercise powers vested on them and discharge other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective provision of the basic services and facilities to its constituents like the construction of infrastructure facilities such as multi-purpose hall, multipurpose pavement, plaza, sport center and other similar facilities intended primarily to service the needs of the residents of the barangay...xxx”*

**WHEREAS**, one of the priority areas that needs to be given importance is Disaster Risk Reduction and Management programs, calamities of various type being prevalent in the communities brought about by global warming and climate change;

**WHEREAS**, a vital component of disaster risk management is post relief and rehabilitation of the distressed areas and comes with it the necessity of having an evacuation center to house displaced persons;

**WHEREAS**, knowing the role of PAGCOR and its many civic programs, more specifically on sport, education, livelihood, tourism, health programs and on disaster preparedness, as well as the benevolence of the Honorable Chairman and CEO, the Sangguniang Bayan deems it appropriate to seek the agency's assistance;

**WHEREAS**, the municipality has existing evacuation centers located within the vicinity of the poblacion, but apparently inadequate to accommodate all the evacuees being effected by calamities, hence, it is imperative for the LGU to construct a new evacuation center that could cater to the demand of evacuees;

**WHEREAS**, the LGU is at the moment financially incapable of realizing such huge project thus it is constrained to seek the assistance of the Honorable Chairman and CEO of the Philippine Amusement and Gaming Corporation (PAGCOR) to extend financial assistance for the construction of a spacious and conducive evacuation center;

**NOW, THEREFORE, BE IT, AS IT IS HEREBY RESOLVED** to earnestly and humbly request Hon. Andrea D. Domingo, Chairman and Chief Executive Officer, Philippine Amusement and Gaming Corporation (PAGCOR) to provide financial assistance amounting to one Hundred Million Pesos (P100,000,000.00) for the construction of an evacuation center in the Municipality of San Nicolas, Ilocos Norte.

**RESOLVED FINALLY** to furnish copy of this Resolution to Hon. Andrea D. Domingo, Chairman and Chief Executive Officer, Philippine Amusement and Gaming Corporation (PAGCOR) for her favorable consideration and approval.

On motion of Member Moera Joy N. Galing-Luna, duly seconded, foregoing resolution was unanimously approved.


