### “RESOLUTION NO. 2021-38

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE SAN PABLO SMALL WATER IMPOUNDING SYSTEM IRRIGATORS ASSOCIATION (SWISIA) INC. FOR THE GRANT OF ONE (1) UNIT 4-WHEEL TRACTOR WITH COMPLETE ACCESSORIES.**

**WHEREAS**, the “LGU-San Nicolas” is primarily tasked, by virtue and existing laws of the land, to assist and/or support various qualified farmer organizations and cooperatives in establishing various projects and programs geared towards agricultural development;

**WHEREAS**, the “LGU-San Nicolas” spearheads the provision of agricultural projects particularly farm machineries and equipment and post-harvest facilities to the different farmers association and cooperative of the municipality;

**WHEREAS**, the “Farmer Organization” is of good standing and duly registered Farmer’s Association under the Securities and Exchange Commission (SEC) and accredited as Rural Based Organization (RBO) by the LGU-San Nicolas;

**WHEREAS**, the “Farmer Organization” has been yearning to have 4-Wheel Tractor to be used in their agricultural land areas;

**WHEREAS**, the “LGU-San Nicolas” shall grant the “Farmer Organization” one (1) unit 4-Wheel Tractor for them to use in barangay and adjacent barangays;

**WHEREAS**, the 4-Wheel Tractor will address the problem of cultivating agricultural land in the barangay and the locality as well;

**WHEREAS**, the “Farmer Organization” shall operate and maintain the production facility (4-Wheel Tractor) at their own expense to efficiently improve production activities;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

*(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.*

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

*Section 444. The Chief Executive: Powers, Duties, Functions and Compensation. – xxx*

*(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:*

*(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”*

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

**RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter Into a Memorandum of Agreement (MOA) with the San Pablo Small Water Impounding System Irrigators Association (SWISIA) Inc. for the grant of one (1) unit 4-wheel tractor with complete accessories.

**RESOLVED, FURTHER**, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;

On motion of Member Norberto D. Dadiz, Sr., duly seconded, foregoing resolution was unanimously approved.


