WHEREAS, the Municipality of San Nicolas has an available Retained Earnings for CY 2020 amounting to Twenty Three Million Five Hundred Ninety Three Thousand Nine Hundred Fifteen and 26/100 Pesos (P23,593,915.26);

WHEREAS, there are programs, projects and activities which are considered to be priority and need to be implemented;

WHEREAS, some of the PPAs were not included in the AIP for CY 2021 and some have insufficient funding, hence, the need for Supplemental AIP;

WHEREAS, after a thorough study of the Committee on Finance, Budget and Appropriations, it was found out that the said Supplemental Annual Investment program is in order;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN IN SESSION, to approve the Supplemental Annual Investment Program of the Municipality of San Nicolas, Ilocos Norte for Calendar Year 2021 as embodied in the Municipal Development Council Resolution No. 2021-01, copy of the same is hereto attached;

WHEREFORE, on motion of Member Luciano R. Caraang, duly seconded, the foregoing resolution was unanimously approved.


RESOLVED FURTHER to transcribe copies of this resolution and furnish the same to the Local Chief Executive and to all concerned, for their reference and guidance.
