### **“RESOLUTION NO. 2021-124**

#### **A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE HOME DEVELOPMENT MUTUAL FUND (PAG-IBIG FUND) FOR THE IMPLEMENTATION OF THE ONLINE STL APPLICATION THROUGH VIRTUAL PAG-IBIG.**

**WHEREAS**, Pag-IBIG Fund shall extend an additional facility in availing the loan program of the Fund by implementing the Online Short-Term Loan (STL) Application through Virtual Pag-IBIG;

**WHEREAS**, Local Government Unit of San Nicolas supports Pag-IBIG Fund’s program and agrees to certify and confirm the STL application of its employees and submits online to Pag-IBIG Fund;

**WHEREAS**, the Pag-IBIG Fund and Local Government Unit of San Nicolas through their Authorized Approving Officer (AAO) agree to cooperate with and assist one another in the implementation of the Online STL Application through Virtual Pag-IBIG;

**WHEREAS**, Sec. 22(c) of R.A. 7160, otherwise known as the Local Government Code, provides, that:

*Sec. 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:*

xxx

xxx

*(c) Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall.*

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444(b)(1)(vi) thereof which provides:

*Section 444. The Chief Executive: Powers, Duties, Functions and Compensation.*

– xxx

*(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:*

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance.”

**WHEREAS**, after thorough deliberation and consideration of the members of the Sangguniang Bayan, it was:

**RESOLVED** as it is hereby **RESOLVED** by the Sangguniang Bayan assembled in session, to authorize the Local Chief Executive to Enter into a Memorandum of Agreement (MOA) with the Home Development Mutual Fund (Pag-IBIG Fund) for the implementation of the Online STL application through Virtual Pag-IBIG;

**RESOLVED, FURTHER**, to transcribe copies of this resolution to the Local Chief Executive and all concerned, for their information and appropriate action;


On motion of Member Jessie Julito P. Pumaras, Sr., duly seconded, foregoing resolution was unanimously approved.
