A RESOLUTION ADOPTING/APPROVING THE PROPOSED PROGRAMS/PROJECTS/ACTIVITIES TO BE FUNDED OUT OF THE 20% DEVELOPMENT FUND OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE FOR CALENDAR YEAR 2022 AS EMBODIED IN THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2020-03.

WHEREAS, the municipality is expecting the amount of One Hundred Sixty Two Million Five Hundred Forty Eighty Thousand Pesos (P164,162,548.00) as its Internal Revenue Allotment (IRA) share for the year 2022;

WHEREAS, 20% of the total IRA amounting to Thirty Two Million Five Hundred Nine Thousand Six Hundred Pesos (P32,832,509.60) is set aside as the Development Fund of the municipality;

WHEREAS, the proposed programs, projects and activities were presented to the Body for their comments, suggestions and recommendations;

WHEREAS, after careful review and deliberation on the identified programs, projects and activities, the Body came out with the final list, to wit:

WHEREFORE, on motion of Member Luciano R. Caraang, duly seconded, the foregoing resolution was unanimously approved.






