“RESOLUTION NO. 2021-131

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE EDUARDO M. AÑO, SECRETARY OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE PROVISION OF FIRE TRUCK IN THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE.

WHEREAS, one of the key programs of the Local Government Unit of San Nicolas, Ilocos Norte, is the protection and preservation of life, limb, and properties of its constituents;

WHEREAS, the municipality is rapidly becoming the business hub not only in the province but in the entire region, where the two tallest buildings (a 12-storey hotel and a 12-storey condominium) up north are now located and other big business establishments such as the Robinsons Ilocos Mall, Save More Supermart, Call Centers, restaurants, prime car dealers and resort hotels;

WHEREAS, to date the municipality has one rundown fire truck and a mini-fire truck which may no more efficiently respond in cases of immense conflagration;

WHEREAS, there is a need to acquire modern and responsive fire trucks and equipment in order for the municipality to efficiently suppress and effectively prevent destructive fires and provide emergency rescue services;

WHEREAS, the municipality has limited and meager resources for the acquisition of fire trucks, thus, we are constrained to seek assistance from the benevolent Hon. Secretary of the DILG our genuine partner for the development of the local government unit;

WHEREAS, the advent of RA 11589, otherwise known as the BFP Modernization Act is very timely, as this law mandates the National Government Agency concerned to provide LGUs with modern firefighting equipment, primarily aimed to cope up with the advancement of building structures and intensify its drive to prevent the loss of lives and properties;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to request the Honorable Eduardo M. Año, Secretary of the Department of the Interior and Local Government for the Provision of Fire Truck in the Municipality of San Nicolas, Province of Ilocos Norte;

RESOLVED, FURTHER, to furnish copy of this Resolution to Hon. Eduardo M. Año, Secretary of the DILG for his utmost consideration.


