**“MUNICIPAL ORDINANCE NO. 2021-24**

**AN ORDINANCE AMENDING SECTION 4 AND SECTION 6 OF MUNICIPAL ORDINANCE NO. 2021-20 OTHERWISE KNOWN AS AN ORDINANCE GRANTING A FIFTEEN PERCENT (15%) DISCOUNT IN THE RENTAL FEES IMPOSED BY THE LOCAL GOVERNMENT UNIT TO LESSEES OF STALLS, BOOTHS, KIOSKS AND SPACES AT THE SAN NICOLAS PUBLIC MARKET FOR THE PERIOD OF JULY 1, 2021 TO DECEMBER 31, 2021.**

**BE IT ENACTED** by the Sangguniang Bayan of San Nicolas, Ilocos Norte in session duly assembled, that:

**SECTION 1.** Section 4 and Section 6 of Municipal Ordinance No. 2021-20 provides, that:

“SECTION 4. *Grant of 15% Discount.* A fifteen percent (15%) discount is hereby granted to all rental fees imposed upon by the LGU to lessees of stalls, kiosks, booths and spaces at the San Nicolas Public Market on the condition that the said lessees have valid and subsisting Business Permit.

SECTION 6. *Effectivity.* This Ordinance shall commence and takes effect on July 1, 2021 until December 31, 2021.”

**SECTION 2.** Section 4 and Section 6 of Municipal Ordinance No. 2021-20 is hereby amended to, to wit:

“SECTION 4. *Grant of 30% Discount.* A thirty percent (30%) discount is hereby granted to all rental fees imposed upon by the LGU to lessees of stalls, kiosks, booths and spaces at the San Nicolas Public Market on the condition that the said lessees have valid and subsisting Business Permit.

SECTION 6. *Effectivity.* This Ordinance shall take effect upon approval.”

**SECTION 3. *Repealing Clause.*** - All previous issuances, ordinance, rules and regulations, provisions or parts thereof, which are inconsistent or in conflict with the provisions of this Ordinance, are hereby repealed or modified accordingly.

**SECTION 4. *Effectivity Clause.*** This Ordinance shall take effect upon approval.


