“RESOLUTION NO. 2021-142

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF GALLOTECHVENTURES INCORPORATED IN PUTTING UP PAGCOR LICENSED OFF- COCKPIT BETTING STATIONS (OCBS) OUTLETS, WITHIN THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, the GallotechVentures Incorporated a duly registered corporation under existing laws, desires to put up a gaming facility, an off-cockpit betting stations within the municipality of San Nicolas, Ilocos Norte;

WHEREAS, it must be noted that the gaming facility is a PAGCOR licensed establishment and thus shall be wholly responsible for its operation;

WHEREAS, it is the belief of the Sangguniang Bayan that the establishment and operation of an off-cockpit betting stations in the locality will boost the influx of tourists in the locality and at the same time provide the much needed revenue to fund the various programs, projects and activities of the municipality that will ultimately redound to the benefit of the people;

WHEREAS, the Sangguniang Bayan interposes no objection to the establishment and operation of the said business entity, subject to the following conditions;

1. The off-cockpit betting station shall be subject to the existing regulations on gaming site locations of E-Bingo and E-Games stations;
2. The applicant must comply with all the necessary documentary and financial requirements as imposed by the PAGCOR;
3. The applicant shall comply with applicable laws, rules, regulations and relative ordinances as to the establishment of E-Sabong (Off-Site Cockpit betting Station);

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to interpose “No Objection” in putting up an OFF-COCKPIT betting stations, a PAGCOR licensed establishment, within the municipality of San Nicolas, Ilocos Norte”;

RESOLVED, FURTHER, to furnish copies of this resolution to all concerned parties for their information and guidance;


