#### **"MUNICIPAL ORDINANCE NO. 2021-29**

AN ORDINANCE REVERTING THE AMOUNT OF THREE MILLION ONE HUNDRED SIXTY TWO THOUSAND NINE HUNDRED FORTY ONE PESOS AND 53/100 (P3,162,941.53) FROM THE MAINTENANCE AND OTHER OPERATING EXPENSES SAVINGS FROM JANUARY TO OCTOBER 2021 TO THE GENERAL FUND AND APPROPRIATING THE AMOUNT OF THREE MILLION ONE HUNDRED FIFTY EIGHT THOUSAND THREE HUNDRED THIRTY FOUR PESOS (P3,158,334.00) FOR THE GRANT OF COLLECTIVE NEGOTIATION AGREEMENT INCENTIVE TO QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPALITY.

**WHEREAS**, there exists an available fund in the amount of Three Million One Hundred Sixty Two Thousand Nine Hundred Forty One Pesos and 53/100 (P3,162,941.53) representing Maintenance and Other Operating Expenses Savings from January to October 2021.

**WHEREAS**, the amount of Three Million One Hundred Sixty Two Thousand Nine Hundred Forty One Pesos and 53/100 (P3,162,941.53) shall be reverted to the General Fund and the amount of Three Million One Hundred Fifty Eight Thousand Three Hundred Thirty Four Pesos (P3,158,334.00) shall be appropriated for the grant of Collective Negotiation Agreement Incentive to Qualified Municipal Officials and Employees of the municipality;

WHEREFORE, BE IT ENACTED, by the Sangguniang Bayan duly assembled that:

**SECTION 1.** The Supplemental Budget No. 3 of the Municipality of San Nicolas, Ilocos Norte for Fiscal Year 2021 in the total amount of Three Million One Hundred Fifty Eight Thousand Three Hundred Thirty Four Pesos (P3,158,334.00) is hereby approved.

The budget documents consisting of the following are incorporated herein and made integral part of this Ordinance:

- 2. LBP Form No. 9 Statement of Supplemental Appropriation CY 2021.

**SECTION 2**. *Sources of funds.* The sources of funds for the Supplemental Budget No. 3 in the total amount of Three Million One Hundred Sixty Two Thousand Nine Hundred Forty One Pesos and 53/100 (P3,162,941.53) shall be from the allowable Maintenance and Other Operating Expenses Savings, as follows:
