“MUNICIPAL ORDINANCE NO. 2021-33

AN ORDINANCE SUSPENDING THE PAYMENT OF MTOP AND INSPECTION FEE OF ALL TRICYCLES FOR-HIRE, GRANTED FRANCHISE TO OPERATE, WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE FOR CALENDAR YEAR 2022.

WHEREAS, the world is still in tatters, the economy stumbling and reeling due to the effects of the dreaded COVID-19 pandemic, making it hard for almost all sectors of society to cope up with its economic backlash;

WHEREAS, the Micro-Small and Medium Enterprises bore the most negative impact, as the movement of people were limited bringing standstill to their operation and ultimately caused huge losses;

WHEREAS, operators of tricycles were not spared and they have to deal with the stringent protocols slowing down their operation;

WHEREAS, pursuant to the Local Government Code, the Sangguniang Bayan is clothed with authority to enact ordinances and approve resolutions for the benefit and welfare of the people especially in times of calamities and occurrences such as the COVID-19 pandemic;

WHEREAS, to mitigate the hardships of tricycle operators and drivers of the municipality, and help them cope up with these difficult times, the Sangguniang Bayan hereby **ORDAINS, THAT:**

SECTION 1. Short Title. This ordinance shall be known as the “Exemption from payment of MTOP and Inspection Fee ordinance.”

SECTION 2. Authority. RA 7160 provides among others, that the Sangguniang Bayan may decree the suspension of the implementation of the provisions of the Local Tax Code, in consideration of justifiable surrounding circumstances.

SECTION 3. Grant of Exemption. All tricycle operators with valid and subsisting franchises shall be exempt in paying the MTOP in the amount of P100.00 and inspection fee in the amount of P100.00 as prescribed by the Local Tax Code of the Municipality for Calendar Year 2022.

Fees other than the MTOP and inspection fee imposed upon the operation of tricycles shall continue to take effect.

SECTION 4. Separability Clause. If for any reason, any section, provision or item of this Ordinance shall be held to be unconstitutional or invalid by competent authority, such judgment or action shall not affect or impair the other sections or provisions hereof.


SECTION 5. Effectivity. This ordinance shall take effect on January 1, 2022.
