RESOLUTION NO. 2021-149

A RESOLUTION CONCURRING THE APPOINTMENT OF MRS. CECILIA I. SAMBRANO AS MUNICIPAL AGRICULTURIST OF THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.

WHEREAS, the provisions of Rule XVIII, Art. 119 of the Rules Implementing the Local Government Code of 1991, requires that the appointment of heads of departments by the Mayor including the position of Municipal Agriculturist must be concurred by the majority of all the Sangguniang Bayan Members, subject to the Civil Service Laws, Rules and Regulations;

WHEREAS, the position of Municipal Agriculturist has been vacated due to the retirement of Mrs. Norma Calamayan, the former Municipal Agriculturist;

WHEREAS, on November 8, 2021, MRS. CECILIA I. SAMBRANO was appointed by the Municipal Mayor as the new Municipal Agriculturist after consideration of her qualifications as prescribed by existing laws and the Civil Service Commission's rules and regulations;

WHEREAS, MRS. CECILIA I. SAMBRANO having found to possess the minimum qualifications required for the position of Municipal Agriculturist, the Sangguniang Bayan hereby concurs with her appointment made by the Local Chief Executive;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to concur/confirm as the Sangguniang Bayan hereby concurs to confirm the appointment of Mrs. Cecilia I. Sambrano as the Municipal Agriculturist of San Nicolas, Province of Ilocos Norte.
