“MUNICIPAL ORDINANCE NO. 2021-34

AN ORDINANCE GRANTING DISCOUNT IN THE AMOUNT OF TWO HUNDRED PESOS (P200.00) ON THE MAYOR'S PERMIT FEE FOR CALENDAR YEAR 2022, TO ALL KINDS OF BUSINESSES OPERATING WITHIN THE MUNICIPALITY OF SAN NICOLAS, ILOCOS NORTE.

EXPLANATORY NOTE

The COVID-19 pandemic is still lurking around and even mutating to various variants, baffling and sending chaos in the business sector and has obviously depleted the economies of all states. Many businesses especially the Micro-Small, Medium Enterprises (SMEs), which carried the brunt of this plague, suffered huge losses and have to close their operations because of their tight condition in coping up with the pandemic and have to terminate the services of their employees, causing a lot of lost jobs and ultimately, livelihood of people.

Towards this end, the LGU continues to endeavor to help alleviate the predicament of all sectors in society. To grant a discount to all businesses operating in San Nicolas, on their Mayor's Permit fee is at hand and it is of the belief of the LGU that how meager the amount maybe, it could still bring a ray of hope to this sector, that not so long from now, everything will return to normalcy.

BE IT ENACTED, BY THE SANGGUNIANG BAYAN ASSEMBLED IN SESSION THAT:

SECTION 1. *Short Title.* This ordinance shall be known as “An ordinance granting discount on the Mayor's Permit Fee for Calendar Year 2022 to all businesses operating in San Nicolas, Ilocos Norte.”

SECTION 2. *Authority.* The Local Government Code empowers municipalities to grant reasonable reduction or discount on fees, or exemptions of payment, as provided under their Local Tax Code under justifiable circumstances.

SECTION 3. *Grant of Discount.* There is hereby granted a uniform discount of P200.00 on the Mayor's Permit fee as provided under the Local Tax Code duly enacted and approved by the LGU.

Municipal Ordinance No. 2021-34;

SECTION 4. Coverage. All existing businesses operating in the municipality regardless of capitalization, shall be granted a uniform P200.00 discount on their Mayor’s Permit fee for the Year 2022.

SECTION 5. Effectivity. This ordinance shall take effect on January 1, 2022.


