“MUNICIPAL ORDINANCE NO. 2022-01

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2021-33 OTHERWISE KNOWN AS, “AN ORDINANCE SUSPENDING THE PAYMENT OF MTOP AND INSPECTION FEE OF ALL TRICYCLES FOR-HIRE, GRANTED FRANCHISE TO OPERATE, WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE FOR CALENDAR YEAR 2022”.

BE IT ENACTED by the Sangguniang Bayan of San Nicolas, Ilocos Norte in session duly assembled, that:

SECTION 1. Title, Section 1 and Section 3 of Municipal Ordinance No. 2021-33 provides, that:

“AN ORDINANCE SUSPENDING THE PAYMENT OF MTOP AND INSPECTION FEE OF ALL TRICYCLES FOR-HIRE, GRANTED FRANCHISE TO OPERATE, WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE FOR CALENDAR YEAR 2022”

SECTION 2. The Title, is hereby amended as follows:

“AN ORDINANCE SUSPENDING THE PAYMENT OF MTOP OR ONE HUNDRED PESOS (P100.00) DISCOUNT ON MAYOR’S PERMIT FEE WHICHEVER IS APPLICABLE AND INSPECTION FEE OF ALL TRICYCLES FOR-HIRE, GRANTED FRANCHISE TO OPERATE, WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN NICOLAS, PROVINCE OF ILOCOS NORTE FOR CALENDAR YEAR 2022”

SECTION 3. Section 1 and Section 3, is hereby amended as follows:

“SECTION 1. *Short Title.* This ordinance shall be known as the “Exemption from payment of MTOP or Discount on Mayor’s Permit Fee and Inspection Fee ordinance.”

“SECTION 3. *Grant of Exemption.* All tricycle operators with valid and subsisting franchises shall be exempt in paying the MTOP or discount on

Mayor's Permit Fee whichever is applicable in the amount of P100.00 and inspection fee in

Page 2, Municipal Ordinance No. 2022-01;

the amount of P100.00 as prescribed by the Local Tax Code of the Municipality for Calendar Year 2022".

Fees other than the MTOP or Mayor's Permit Fee and inspection fee imposed upon the operation of tricycles shall continue to take effect.

SECTION 4. Separability Clause. If for any reason, any section, provision or item of this Ordinance shall be held to be unconstitutional or invalid by competent authority, such judgment or action shall not affect or impair the other sections or provisions hereof.

SECTION 5. Effectivity. This ordinance shall take effect upon approval.
